SUBJECT : 4th A HAPPY MISOR SCOUTS JAMBOREE

1. In consonance with DepEd Order No. 74, s. 2012 re Revitalizing Scouting Movement in the entire country, we are pleased to announce the conduct of the 4th A Happy MisOr Scouts Jamboree on December 1-4, 2016 at San Francisco de Asis Elementary School, El Salvador City, Misamis Oriental with the theme: "Scouts: Make MisOr Happy".
2. The Jamboree aims to provide meaningful activities for the Scouts and an avenue to showcase their knowledge and skills in Scouting and leadership, enabling them to become a well-rounded individual, self-reliant and useful citizen of the country. It also seeks to inculcate values such as patriotism, nationalism, care for the environment and camaraderie while participating in outdoor-based non-formal education and the BSP Peace initiative.
3. The 4th A Happy MisOr Scouts Jamboree offers participating Scouts the opportunity to experience the outdoor life, learn new skills and enhance their camp craft abilities, gain advancement requirements and engage fellow Scouts in doing significant contributions to make MisOr Happy.
4. The qualifications for participation are as:
 - a. Currently registered to the Boy Scouts of the Philippines as KID Scout, KAB Scout, Boy Scout, Senior Scout, Rover Scout and IH/Unit Leader/Outfit Advisor/Scout Volunteer;
 - b. Physically fit as certified by a physician;
 - c. Have good leadership potentials;
 - d. Have camping gears and equipment; and,
 - e. Have parent's permit.
5. A registration of FOUR HUNDRED PESOS (Php 400.00) will be charged each participant to cover expenses for souvenir item/s, certificate, ID, Administrative cost, Jamboree materials and other operational expenses.

6. Considering the nature of the activity, contingents of each Scouting district/institution must provide their own food and other basic requirements that will be sufficient throughout the whole duration of the Jamboree. Wet and Dry Markets will be available at the Jamboree Site in order to ensure availability of food supplies at reasonable price.
7. Jamboree expenses may be charged to Local Funds or Local School Board Funds/Other funds subject to the approval of the Local Chief Executive and to the usual accounting and auditing rules and regulations or personal funds.
8. District Scouting Committees are encouraged to create respective Jamboree Committee and promote the Jamboree in all schools to ensure maximum participation.
