Subject : ANNUAL LOCAL COUNCIL MEETING AND ELECTION

Date : April 30, 2014

1. The Boy Scouts of the Philippines-Misamis Oriental Council is pleased to announce the holding of the 2014 Annual Local Council Meeting (ALCM) on May 8, 2014 at 1:00 PM at the Philtown Hotel, Cagayan de Oro City.

2. The meeting aims to achieve the following:

- a. Render reports;
- b. Elect four (4) Regular Members of the Local Council Executive Board to serve for a term of three (3) years;
- c. Elect ten (10) Private Sector Representatives to serve for a term of one (1) year; and,
- d. Elect the Local Council Officers (Executive Committee) to serve for a term of one (1) year.

3. The following are qualified to make and submit nominees for the members of the Local Council Executive Board:

- a. Council Officers, Local Council Executive Members and Other Council Members in Good Standing;
- b. District Commissioners (Public Schools District Supervisors) and District Chairmen; and,
- c. Institutional Heads/Principals from Public and Private Elementary and Secondary Schools.

4. The official delegates, who must be duly-registered with the Boy Scouts of the Philippines-Misamis Oriental Council, shall be the following:

- a. Council Officers and Members of the Local Council Executive Board with voting privilege;

- b. District Commissioners, District Chairmen, Area Chairmen, and Registered Institutional Representatives with voting privilege;
 - c. Institutional Heads/Principals of Public and Private Elementary and Secondary Schools and Rover Circle Managers;
 - d. Registered Institutional Representatives and District Coordinators.
5. Duly accomplished nominations forms must be submitted to the Nominations and Election Committee on or before May 7, 2014 at the office of the Boy Scouts of the Philippines-Misamis Oriental Council.
6. The following election procedures shall be strictly observed:
- a. There shall be no nominations from the floor during the Annual Local Council Meeting.
 - b. Nominations must be made through the Nominations and Elections Committee;
 - c. Voting by PROXY is not allowed.
 - d. Election shall be done by secret ballot.
7. Wide dissemination of this Memorandum is highly enjoined.
