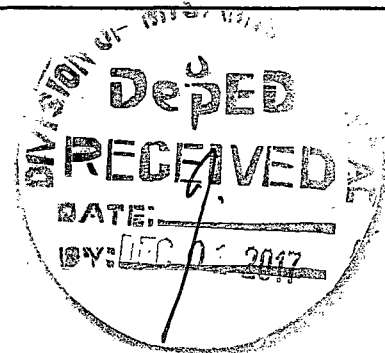





**CALL FOR PAPERS**

The call for papers is governed by the following guidelines and procedures.

All educational institutions and agencies, whether public or private are eligible to submit research outputs relevant to the theme "Nurturing Competencies of Career and Employment Counselors and Advocates through Research".

**ORAL PRESENTATION GUIDELINES**

1. Authors are requested to submit electronically a **300-word abstract** and a **full paper of 15-20 pages** (with references) to the following email addresses: [acejuly27@yahoo.com](mailto:acejuly27@yahoo.com) or [cgn10@yahoo.com](mailto:cgn10@yahoo.com) on or before December 8, 2017.
2. The paper must be **single-spaced** using **Arial type font (12 pts)** preferably in Word File format.
3. The presentation must include the title at the top followed by a brief **background or introduction, objectives or problems, methodology, summary of findings, conclusions, recommendations, and bibliography.**
4. All research presentations shall be allotted 20 minutes for delivery in powerpoint and 10 minutes for open forum.
5. The best presenter shall be awarded certificate of recognition based on the following criteria:
