 - e. Available and needed facilities for identified public schools
 - f. Partnership arrangements on teaching complement and immersion opportunities with non-DepEd partners/ privates schools/ higher education institutions, technical-vocational institutions, local government, industries, government agencies and non-government organizations(with MOA/ MOU)
 - g. Gather needed data for the development / improvement / refinement of the SDO SHS Implementation
 - h. Engage relevant stakeholders in the success/ refinement of the SDO SHS Implementation
 - i. Facilitate communication of SHS implementation updates to all stakeholders
 - j. Ensure the timely and proper execution of the SDO SHS Implementation
 - k. Provide regular updates to the Regional Director and the Undersecretary for Governance and Operations

1. Monitor regularly the SHS Implementation, consolidate the findings/observations and submit the consolidated data and give needed Technical Assistance to the identified schools.
