1. Pursuant to DepEd Order No. 13, s. 2022 entitled Omnibus Guidelines on the Regulation of Parent-Teacher Associations (PTAs), DepEd Order No. 47, s. 2014, DepEd Order No. 49, s. 2011, and DepEd Memorandum No. 55, s. 2021, this Office hereby reiterates the authorized and voluntary school contributions that can be collected through the Parent-Teacher Associations (PTAs) and Recognized School Organizations/Clubs, to wit:

(Amount shall be determined by the Organizations/Clubs Officers consulted with the students and endorsed by the School Head subject to the approval of the Division Office as duly recognized organizations and clubs and can be collected separately by the recognized Organizations/Clubs Officers per aforementioned DepEd issuances and deposited in a separate bank account)</p>
Boy Scouts of the Philippines (BSP)	P 50.00
Girl Scouts of the Philippines	P 50.00
School Publications: Elementary	P 60.00
Secondary	P 90.00
Anti-TB Fund Drive	P 5.00

2. Consistent with the existing laws, rules and regulations implementing DepEd's "No Collection Policy", the collection of the VSCs shall only be allowed provided that the collection of VSCs and performance of other financial transactions shall only be allowed whenever they support the programs, projects, and activities identified in the SIP and it shall be done in close coordination with the Homeroom Adviser, SPG/ SSG Advisers, Club Advisers, and/or the School Head concerned.

3. All PTA collections shall begin on the third (3rd) month from the start of the classes until the end of the SY and shall be guided by the following:

3.1 Kindergarten to Grade 4 Learners. Only PTA Membership Dues shall be collected.

3.2 Grade 5 to 12 Learners. The aforementioned DepEd-authorized VSCs that may be collected from these learners.

4. **In no case shall the non-payment of VSCs shall be made as a basis for non-admission, non-promotion, or non-issuance of a Report Card, Certificate of Good Moral Character, and/or School Clearance or denial of any benefit to a student by the school concerned.**
