1. Please be informed that **Fire Drills** shall be conducted in all schools at 9:00 AM on **March 15, 2017** and **August 3, 2017** and **Earthquake Drill** at 9:00 AM on **June 23, 2017** and **November 24, 2017**. Attached is the Regional Advisory No. 24, s. 2017, the content of which is self-explanatory. A National Advisory relative to the conduct of Fire and Earthquake Drills shall also be implemented and followed.
2. The School DRRM Coordinator shall tap the services of the Local BFP, PNP and DRRMC personnel in their respective áreas as raters/observers during the drills.
3. In this regard, the PSDS shall submit a consolidated report using the NSED Template. Kindly see attached consolidated NSED Template for the reporting.
