**ADDENDUM-CORRIGENDUM TO DIVISION MEMORANDUM No. 224, s. 2022**  
**re: CONDUCT OF THE 2021 NATIONAL QUALIFYING EXAMINATION**  
**FOR SCHOOL HEADS**

1. Pursuant to DepEd Memorandum No. 033, s. 2022 re: Conduct of the 2021 National Qualifying Examination for School Heads, the **2021 National Qualifying Examination for School Heads (NQESH)** and Regional Memorandum No. 246 and 253, s. 2022 of the same title, this is to announce to interested applicants the additional provisions for the conduct of the said exam.
2. As stated in Paragraph 4 of Division Memorandum No. 33, s. 2022, “the 2021 NQESH online examination shall only be limited to **a total of 6,000 examinees nationwide**. Each region, therefore, shall only be provided slots based on the number of *unfilled* Principal I positions.” Region X has only 150 slots available. From the 150 slots of Region X, **SDO Misamis Oriental has only 14 slots for the 2021 National Qualifying Exam for School Heads (NQESH)**.
3. Further, as stated in the same Paragraph, that a prioritization scheme in two batches will be followed in the selection of applicants, to wit;
  - a. *Incumbent Officer-in-Charge (OIC)/TIC for at least two years of Head Teacher for at least one year of a public elementary or secondary school with designation of Special Order duly signed by the Schools Division Superintendent;*
  - b. *In case of remaining slots after considering (a), only then that the applications of the following may be accommodated:*
    - i. *Qualified applicants based on Paragraph 2 of this Memorandum*
    - ii. *Incumbent OICs/TICs not meeting the required experience.*

In addition, considering that most of the interested applicants are qualified for the first and second prioritization batches stated in Paragraph 4 of DepEd Memorandum No. 4, s.2022, this Office will also consider the *length of service* of the incumbent TIC/SIC/OIC in his/her current position as TIC/SIC/OIC and *Performance Rating* in the selection of applicants for the NQESH.

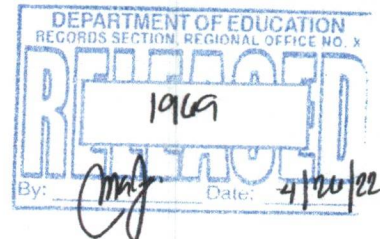
