2. Team A and Team B members may be interchange as replacement to another in the absence or non-availability of member/s of the inventory schedule for valid reason.
3. The following are the roles and responsibilities of the Division Inventory Committee, to wit:
  - a.) Plan and strategize on how to conduct and complete physical inventory within the prescribed period and shall prepare physical inventory plan (PIP). It shall be submitted to COA.
  - b.) Responsible for the actual count to ascertain the existence, completeness and condition of all inventory items and PPEs.
  - c.) Prepare and submit the final inventory reports together with inventory findings and recommendations to Head of the Agency.
  - d.) Establish accountability and responsibility over PPEs.
  - e.) Adhere to the prescribed guidelines on Inventory Taking based on the stated COA Circular and DepED Property Manual.
  - f.) Perform other inventory-related duties and responsibilities.
4. The conduct of inventory taking is an indispensable procedure for checking the integrity of property custodianship. Thus, the Division Inventory Committee shall conduct physical count on select schools of DepED Misamis Oriental from July 3, 2023 to August 31, 2023.
5. Travel and/or transportation expenses and other allowable expenses incurred by the committee in performing their tasks shall be charged against Division MOOE funds.
6. Section 5.3 of COA Circular 2020-006 states that *"The members of the Inventory Committee shall be temporarily relieved of all their regular duties to devote their full time in the conduct of the physical inventory taking until the same is completed."* Moreover, the said Committee shall religiously observe the approved Physical Inventory Plan (PIP).
