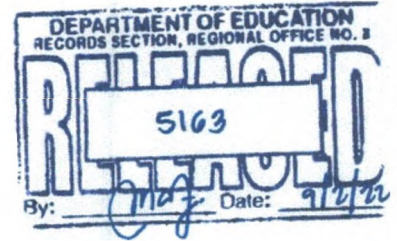

**SUBJECT: NATIONAL ROLLOUT OF COMPREHENSIVE SEXUALITY
EDUCATION (CSE) INTEGRATION IN THE CURRICULUM**

DATE: 18 AUGUST 2022

The Department of Education through the Bureau of Curriculum Development (BCD) in coordination with the United Nations Population Fund (UNFPA), Center for Health Solutions and Innovations Philippines, Inc. (CHSI) and Commission on Population and Development (POPCOM,) shall conduct a National Rollout of CSE Integration in the Curriculum through a national and regional workshop on September 26-30, 2022, in Cebu City.

The activity aims to (1) provide technical updates on CSE integration in the K to 12 curriculum; (2) foster collaboration between and among program managers and implementers to intensify support for the implementation of CSE; (3) and develop a CSE regional action plan for 2023-2025, including activities on capacity building, communications and advocacy, and monitoring and evaluation.

The activity will be conducted through in-person and online platform (via Zoom and FB Livestream). The expected participants are CSE regional focal persons, division and district supervisors, school heads, and teachers. However, CSE regional focal persons and participants from Regions 6, 7, and 8 are requested to attend in-person while the rest of the participants (from other regions not mentioned) are expected to attend virtually.

For those attending in-person, first meal is lunch on 26 September 2022 while check in is at 1:00 P.M. Board and lodging, travel expenses, and other incidental expenses of participants from CO as well as facilitators, resource persons and participants coming from Regions 6, 7, and 8 are charged against BEC funds; while the travelling expenses of the 13 CSE Regional Focal Persons specifically from Regions 1, 2, 3, 4A, 4B, 5, 9, 10, 11, 12, Caraga, CAR, and NCR, shall be charged against local funds, subject to the usual accounting and auditing rules.
