In consonance with Paragraph 17 of DepEd Order No. 034, s. 2022 titled SCHOOL CALENDAR AND ACTIVITIES FOR THE SCHOOL YEAR 2022-2023, and the Regional Memorandum No. 587, s. 2022, re: Intensive Monitoring in Preparation for the 100-Percent In-person Classes, this Office directs the SGOD Personnel to conduct an Intensive Monitoring for the whole month of October in Preparation for the 100 Percent In-Person Classes considering that starting November 2, 2022, all public and private schools shall have transitioned to 5 days in-person classes.
2. The SGOD Personnel whose names are indicated in the attached Enclosure are guided with the concerns to be scrutinized and to be checked with the use of the enclosed Monitoring Tool.
3. Monitoring activity will take effect on October 11, 2022. SGOD Team will coordinate with the Public Schools District Supervisors/In-charge.
4. Further, SGOD Personnel are encouraged to take pictures during intensive monitoring for documentation purposes.
5. Travel and other expenses in conducting this activity shall be charged to Division Funds, subject to the usual accounting and auditing rules and regulations.
