 - QUALITY:
 - Grade level and no. of learners with grades above 90%
 - Grade level and no. of learners with grades above 80%
 - Grade level and no, of learners with grades below 75%
 - List of least mastered learning competencies per subject area.
 - Issues and concerns that affect performance
 - EFFICIENCY:
 - No. of learners who are No Longer Participating in Learning Activities (NLPAs) and summary of reasons on the no. of NLPAs.
 - GOVERNANCE:
 - No. of SHS graduates employed and finishers who are not employed
 - Summary report on the QATAME for the INSET 2022.
 - District status of liquation report of schools.
