This aims:

- 1. To orient participants of DepEd ORDER No. 13 s., 2017 re: Policy and Guidelines on Healthy Food and Beverage Choices in Schools and DepEd Offices;
- 2. To provide information on how to prepare and serve food to the learners to become responsible food handlers by using safe food handling methods.
- 3. To review the **2018** Supplemental Guidelines on the Implementation of the School Based Feeding Program for FY 2018 and check whether the implementation is in consonance with the guidelines;
- 4. To provide assistance to problems encountered by the School Heads and Feeding teachers in making required reports.

The participants are the Elem Principals/ School Heads and Nurses in Elem Schools. Venue and Food shall be charged against the School Based Feeding Program Fund (Sub-Aro 10-18-210 MFO 310400100001000) while travelling expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
