1. Pursuant to DepEd Memorandum No. 053, s. 2020 entitled **Joint Implementing Guidelines on the 2020 Brigada Eskwela and Oplan Balik Eskwela**, the field is hereby informed of the following schedules on the submission of Brigada Eskwela documents:

**June 26, 2020** – Deadline for the submission of Letter of Intent for BRIGADA ESKWELA PAGBASA in hard copy signed by the school head indicating the category of the school.

**July 3, 2020** – Deadline for the submission of Letter of Intent for BRIGADA ESKWELA SEARCH FOR BEST IMPLEMENTING SCHOOL ( 1 school per category per district signed by the school head and countersigned by the PSDS)

**June 1-August 31, 2020** – Brigada Eskwela Implementation and Monitoring of schools

**August 31, 2020**- Schools submission of Brigada Eskwela Generated Resources and Number of Volunteers to the District Office

**September 4, 2020** – Districts submission of Consolidated Generated Resources and Number of Volunteers to the Division Office

**September 11, 2020** – Submission of Division Consolidated Generated Resources and total number of volunteers to the Regional Office.

2. Schools are encouraged to document all their efforts to implement the new way of conducting Brigada Eskwela. The usual reporting format shall be adopted with highlights on the effort in line with COVID-19 recovery initiatives.
