1. Relative to NDRRMC Memorandum No. 140 s, 2018, all DepEd offices and schools shall participate in the conduct of the **CY 2019 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED)** on June 20, 2019, 2:00 pm.
2. The Divisional Ceremonial venue will be at Talisayan Central School, Misamis Oriental.
3. All School DRRM Coordinators shall tap the services of the Municipal Disaster Risk Reduction and Management Councils (MDRRMC), Local BFP, and PNP in their respective areas as raters/observers during the drills.
4. All School DRRM Coordinators shall also submit Rapid Assessment of Damages Report (**RADAR 1 and RADAR 2**) after the NSED to test drill the submission of such RADAR reports. In the name of the hazard, put 2ndNSED2019 and send to DRRMS feedback numbers 09152053244 and 09178992245.
5. Further, PSDSs shall submit a consolidated report using the NSED Template. See attached consolidated **NSED Template** for the reporting.

6. A scanned copy with the PSDS signature of the NSED Template shall be submitted through email (cirilo.rubiato@deped.gov.ph) on or before **June 28, 2019 (Friday)**.

Rule 6, Section 7 of the Implementing Rules and Regulations of the RA10121 states that "Public awareness shall also be undertaken through the conduct of drills by the LDRRMO on a regular basis". Likewise, the National Disaster Risk Reduction and Management Plan (NDRRMP) states that one of the activities to achieve Outcome 10: "Developed and implemented comprehensive national and local preparedness and response policies, plans and systems" is to develop/ enhance and simulate scenario-based preparedness and response plans and systems". Furthermore, one of the policy framework stated in the National Disaster Preparedness Plan as embedded in the fourth priority area of the Sendai Framework for Action 2015-2030 includes the target: to promote regular disaster preparedness, response and recovery exercises".

In view hereof, the CY 2019 2nd Quarter Nationwide Simultaneous Earthquake Drill (NSED) is scheduled on **20 June 2019, 2:00 PM. The Regional Ceremonial Venue will be at Mambajao, Camiguin.**

The objectives are as follows:

1. To test the efficiency and usefulness of the preparedness, response and recovery plans, systems and policies developed in their respective localities/ offices/ schools;
2. To evaluate the effectiveness of contingency plan;
3. To test the coordination and communications mechanism during response operation;
4. To understand the command and control mechanism in emergency and disaster operations at the DRRMCs.

All RDRRMC member agencies and Chairpersons of all LDRRMCs are enjoined to spearhead the conduct of earthquake drill in their areas of jurisdiction and **submit after activity report 15 days after the conduct of the drill to the Office of Civil Defense Regional Office-10 through electronic mail at ocdr10@gmail.com.**
