

- T. With reference to the August 1, 2018 memorandum from Undersecretary Alain Del B. Pascua, the Bureau of Learning Support Services, through the Youth Formation Division, will spearhead the National Training of Trainers for Teachers and Career Advocates, in support to the implementation of career guidance program, on the August 28-31, at a specific venue to be announced by the Youth Formation Division in a succeeding memorandum.
- 2. The training aims to build the capacity of trainers to conduct the mass training of teachers and career guidance advocates on career guidance strategies and prepare each region's mass training plan.
- 3. The participants from the region are listed in the enclosed document.
- 4. Participants are expected to check in at 3:00 in the afternoon of August 27, 2018 for registration, with dinner as the first meal.
- 5. The participants shall be entitled to service credits in accordance with DepEd Order No. 53, series of 2003 entitled *Updated Guidelines on the Grandt of Vacation Service Credits to Teachers*. Likewise, non-teaching personnel, including management staff, shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission and Department of Budget and Management Joint Circular No. 02, series of 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
- 6. The fund support for the mass training are downloaded to the regions to cover expenses for board and lodging, supplies, and contingencies related to the training.
