**CONDUCT OF DIVISION NATIONAL INDIGENOUS PEOPLES (IP)
MONTH CELEBRATION FOR 2023**

1. In consonance with RM No. 0605 s. 2023, this Division hereby announces the Conduct of National Indigenous Peoples (IP) Month Celebration for 2023.
2. The theme for this year is *Pundasyon ng Katutubong Edukasyon ay Patatagin, Katutubong Karunungan ay Patuloy na Pagyamanin.*
3. Schools may celebrate through any of the following activities:
 - a. IP gathering in the spirit of celebration;
 - b. Provision of spaces where Indigenous Peoples can perform their cultural presentations;
 - c. Hanging of tarpaulins in the SDOs and schools with the theme for this year's celebration;
 - d. Dialogue or Kamustahan with Tribal Elders and CAB
 - e. Advocacy sessions
4. Furthermore, the following shall be submitted through Google Drive which will be provided in the PSDS/DIC Group Chat:
 - a. Pre-recorded video of one (1) cultural presentation, at least 7-8 min. duration
 - b. Background information of the cultural expression/presentation
 - c. Submission of the video format in mp4 on or before **November 6, 2023**
 - d. Pre-recorded video of schools implementing the IPED Program, IP Elders, and other stakeholders

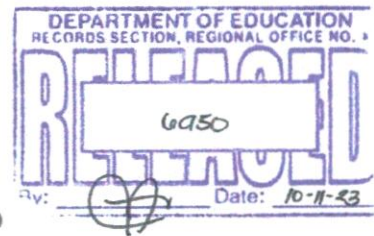

NATIONAL INDIGENOUS PEOPLES (IP) MONTH CELEBRATION FOR 2023

To: Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

1. Presidential Proclamation No. 1906, s. 2009 declares the Month of October of Every Year as the National Indigenous Peoples (IP) Month. This year 2023, the Department of Education (DepEd) Region X is celebrating the 2nd Decade Years of the Indigenous Peoples Education (IPEd) Program.
2. The theme for this year is *Pundasyon ng Katutubong Edukasyon ay Patatagin, Katutubong Karunungan ay Patuloy na Pagyamanin.*
2. This theme is aligned with the call of the MATATAG Agenda to strengthen inclusive education programs like the IPEd Program and contributes to the 2023 call of the National Commission on Indigenous Peoples for the nation to enrich the cultural heritage of IP communities.
4. The SDOs and the schools may celebrate through any of the following:
 - a. IP gathering in the spirit of celebration;
 - b. Provision of spaces where Indigenous Peoples can perform their cultural expressions/presentation;
 - c. Hanging of streamers/tarpaulins in the SDOs and schools with the theme for this year's celebration;
 - d. Wearing of IP Attire during the IP Day Celebration is highly encouraged;
 - e. Dialogue or "Kamustahan" with tribal elders or community representatives and Consultative Advisory Body (CAB) Members; and
 - f. Advocacy sessions with the teaching, nonteaching personnel, and organizations to increase awareness about the IPEd Program.
5. Further, the SDOs shall submit to the set Google Drive the following:
 - a. Pre-recorded video of one (1) cultural expression/cultural presentations;
 - b. At least 7-8-minute duration for each video;
 - c. Background information of the cultural expressions/cultural presentations;
 - d. Submission of the video format in mp4 on or before November 10, 2023; and
 - e. Pre-recorded video of schools implementing the IPEd Program, IP Elders, and other stakeholders as partners in the implementation of the program.
