**INVOLVEMENT OF SCHOOL DIVISION OFFICES, DISTRICT OFFICES,
 AND SCHOOL OFFICIALS TO CITY/MUNICIPAL/
 BARANGAY-ANTI DRUG ABUSE COUNCIL**

To: Public Schools District Supervisors/In- Charge

 All Others Concerned

1. Pursuant to Section 42-44, Article IV of Republic Act 9165 otherwise known as “Comprehensive Dangerous Drug Act of 2002” and DepEd Order No. 12, series of 2009 “Strengthening the National Drug Education Program (NDEP) in School”, this Division advocates the Involvement of School Division Offices, District Offices, and School Officials to City/Municipal/Barangay Anti-Drug Abuse Council (CADAC/MADAC/BADAC).



This aims to strengthen the implementation of NDEP; motivate program implementers to manifest enthusiasm, leadership, and deeper commitments to the implementation of the program; intensify School-LGU collaboration in maintaining an entirely drug-free environment in the school, home, and community; and improve the sustainability of drug prevention advocacy.

3. Further, based on DepEd Order No.30 s. of 2018, Preventive Drug Addiction Program Policy for Curriculum and Instruction, the duties and responsibilities of the School Heads are to coordinate with the appropriate offices and other agencies for appropriate assistance and interventions as may be required in the performance of his/her function as stated below:
