SUBJECT: **ENRICHMENT WORKSHOP ON CONTEXTUALIZED LESSON PLANS
FOCUSED ON CORE KNOWLEDGE**

1. Relative to issued Regional Memorandum No. 731, s. 2019 and Corrigendum to the aforesaid Memorandum, a four-day **Enrichment Workshop On Contextualized Lesson Plans Focused On Core Knowledge** will be conducted on December 10-13, 2019 at Chali Beach Resort, Cugman, Cagayan de Oro City. Pre-work will be on December 9, 8:00 am to 5:00 pm.

2. This activity is aimed at achieving the following:
- Review and discuss the core knowledge and Indigenous Knowledge System (IKSP) in relation to indigenized competencies and cultural standard for IP learner; and
 - Revisit and enhance the contextualized lesson plans for Kindergarten and Grades 1-3 focused on core knowledge; and
 - Submit enhanced lesson plans for community validation, quality assurance and finalization.

3. Teacher-participants must be a practitioner and assigned in the schools serving IP community. IP Elder participants must have previous engagement in the indigenization of lesson plans.

4. The registration fee of Six Thousand Pesos (P6,000.00) will be collected from each participant to defray expenses for the meals and accommodation chargeable to the 2019 division IPed Program Support Funds (IPSF). Travel of the participants and honorarium of IP Elders will also be charge to the 2019 division IPSF, subject to the usual accounting and auditing rules and regulations.


