**COMPUTATION OF PUBLIC SCHOOL TEACHERS' PROPORTIONAL  
VACATION PAY FOR SCHOOL YEAR 2018-2019**

1. This is to provide the uniform basis for the **Computation of the Proportional Vacation Pay (PVP) for School Year (SY) 2018-2019** for all public elementary and secondary school teachers under the teacher's leave basis.

2. For SY 2018-2019, each of the teachers who has rendered continuous service from June 4, 2018 to April 5, 2019 shall be entitled to **77 days total of PVP** from Summer and Christmas vacation days, computed as follows:

Total Number of days served	
from June 4, 2018 to April 5, 2019	306 days
Less: Number of Christmas vacation days earned	
from December 15, 2018 to January 2, 2019	<u>19 days</u>
Actual days served	287 days
Multiply factor	<u>0.268</u>
<b>Total PVP earned from the number of Summer and Christmas vacation days</b>	<b>77 days</b>
Less: Number of Christmas vacation days	<u>19 days</u>
Number of Summer vacation days earned	
from April 6 to June 2, 2019	58 days

3. The factor **0.268** shall be used for the computation of absences and PVP for SY 2017-2018. Below is the **derivation of factor 0.268**.

Number of Summer vacation days	58 days
Add: Number of Christmas vacation days	<u>19 days</u>
<b>Total PVP (Summer and Christmas vacation days)</b>	<b>77 days</b>
Divided by actual days served	287 days
Multiply factor	<b>0.268</b>
