1. - d. supporting the learners in understanding the roots and ramifications of prejudice, racism, and stereotyping in the Philippines or in any society;
- e. fostering critical thinking and identifying danger signals to know when to take constructive action; and
- f. providing an avenue for the International Cooperation Office (ICO) and DepEd to establish partnerships with international stakeholders and develop cooperation and collaboration.

3. The participants for this activity are the permanent divisional partnership focal persons (1 pax per division only), Division of Misamis Oriental officials, and MOGCHS teachers, together with identified learner-participants.

4. Further, at 8:00 a.m. on the same date, the divisional partnership focal persons are instructed to be at the Audiovisual Center (AVC), Third Floor, DepEd Regional Office X, for a half-day First Quarter Meeting regarding the updates on building partnerships and linkages program, adopt-a-school, DepEd Partnerships Database System (DPDS), and other matters.


