1. Per Presidential Proclamation No. 264, the month of September every year is declared as National Science Club Month. In view thereof, every school is encouraged to have their activities in preparation for the conduct of **2016 Division Science Quest** on October 7, 2016 at Vicente N. Chavez Memorial Central School, Villanueva, Misamis Oriental with the following contests:

- a) Water Patrol Dama for Grades 3 and 4;
- b) Power Patrol Dama for Grades 5 and 6;
- c) Electro Sci-Dama for Grade 7;
- d) Dama Sci-Notation for Grade 8;
- e) THI Sci-Dama for Grade 9;
- f) Thermo Sci-Dama for Grade 10;
- g) Investigatory Project (Life Science-Individual) Secondary;
- h) Investigatory Project (Life Science-Team) Secondary;
- i) Investigatory Project (Physical Science-Individual) Secondary;
- j) Investigatory Project (Physical Science-Team) Secondary; and
- k) Science Quiz for Grades 3, 4, 5, 6, 7, 8, 9, 10 and 11

2. Only one participant per school district is allowed to participate in Sci-Dama and Science Quiz. Guidelines on playing sci-dama can be viewed at scidamaths.blogspot.com "How to Play Sci-Damaths" by Nelson B. Absin, Ph.D. Questions for the science quiz are based from competencies in the K-12 Curriculum Guides.

3. Electronic copy of Science Investigatory Project paper should be submitted not later than September 31, 2016 to cbmagsayo@gmail.com. These will be screened to reduce the numerous entries to five per category. Qualified participant will be properly informed. They will then undergo oral defence of their research study on the 7th of October.

4. Meals, traveling and other expenses of the participants (contestants/coaches) are chargeable to school downloaded funds/MOOE or local funds/SEF subject to usual accounting and auditing rules and regulations, while meals, traveling and other expenses of judges and officials shall be charged to division funds subject to usual accounting and auditing rules and regulations.
