## ADDENDUM TO THE DIVISION MEMORANDUM No. 287, S. 2015 RE: "CONDUCT OF THE 2015 PALARONG PANLALAWIGAN -- PAMPAARALAN"

1. This Office hereby announces the final sports events to be conducted during the conduct of the 2015 Palarong Panlalawigan-Pampaaralan, to wit:

NOTE:

- 1. Basketball (Boys Elem/Sec.), Swimming (Boys/Girls), Arnis (Boys/Girls) Archery (Boys/Girls), Badminton, Boxing (Boys) Sec., Volleyball (Girls) Elem. and Gymnastics will be conducted during the 2015 Palarong Panlalawigan, however, the performance of the players of these events will be validated by the selection committee whether they will meet the Regional and National Standards as to the time, height, distance, skills and performance.
- 2. All Demo' Sports such as: Billiards (Boys/Girls) Sec., Sepak Takraw (Girls) Futsal, Wushu and Wrestling will not be conducted.
- 2. That the composition of Delegation Officials (coach, chaperon, kitchen cabinet and staff/delegation officers) shall only be 15% of the total number of the delegation.
- 3. The scheme of the 2015 Palarong Panlalawigan is purely selection of potential athletes to compose the different teams to represent Misamis Oriental to the 2015 Regional Meet. There will be "No Declaration of Champion" for both elementary and secondary levels.

### 4. Rules on Participation

- Participants in the Palarong Panlalawigan shall be elementary and secondary from public and private schools who participated in the lower meets (District/Unit Meets). Secondary level athletes shall refer to athletes coming from Junior High Schools or Senior High Schools.
  - 4.1.1 Secondary level athletes from SHSs shall refer to all Grades 11 or 12 students from DepEd SHSs, private SHS, private Higher Education Institutions (HEIs) offering SHS, State Universities and Colleges (SUCs), and Local Universities and Colleges (LUCs) offering SHS, and other institutions authorized to offer SHS pursuant to existing DepEd Orders, rules regulations.

### 4.2 Eligibility of Athletes

- 4.2.1 To be eligible as participant in the Palarong Panlalawigan, an athlete must be:
- 4.2.2 A Filipino citizen;
- 4.2.3 Enrolled in a recognized school (schools with recognition/permit to operate) at the beginning of the current school year and have attended and/or completed the curriculum year;
- 4.2.4 Should have participated in the preliminary meets (district/unit meets);
- 4.2.5 For elementary athlete, he or she should have born in 2003 or after; and secondary athletes, he or she should have been born in 1998 or after. Thereafter, add one year to the cut-off date for the succeeding year;
- 4.2.6 Pupil/student-athletes who transferred from one region to another are allowed to participate, provided their transfer was done at the beginning of the school year. Transferees from one division to another within the region are allowed to participate, provided they have participated in the lower meets; and
- 4.2.7 As a general rule, elementary athletes shall play in the elementary division and secondary athletes shall play in the secondary division. However, elementary level athletes who have been declared overage in the elementary level may be allowed to play in the secondary level.
- Parents of pupils/students who have any question, query, or clarification relative to these guidelines shall have 30 days from the date of its issuance to file the same with the Office of the Schools Division Superintendent, Division of Misamis Oriental. Failure to file the same within the period herein provided shall constitute a waiver on their part and any question, query, or clarification shall not be entertained except on meritorious grounds.
- 5. All identified Host Districts/Schools shall do the necessary preparations of the playing venues, sports gadget/equipment, including the rooms as billeting quarters and the area for the kitchen and the personnel assigned.
- 6. Immediate dissemination of this Memorandum is hereby desired.
