1. 

1 Pursuant to DepEd Memorandum No. 26, s. of 2016 re Changes in and Additional Information to DepEd Memorandum No. 1, s. 2016 on the administration of Language Assessment for Primary Grades (LAPG) and the National Achievement Test for Grade Six (NAT G6) for School Year 2015-2016, this Office is directing all SDOs to conduct the following activities:

- a Dissemination of the information on the conduct of LAPG and NAT during Brigada Eskwela;
- b Monitoring of schools on their NAT readiness and interventions in the month of May and early part of June; and
- c Conduct of mock test on June 13, 2016 in all schools (public, private, MADRASAH schools)

2. Education Program Supervisors in the region and in the division are required to monitor the conduct of LAPG on June 15, 2016, NAT G6 on June 17, 2016 and NAT G10 on June 23, 2016 to ensure proper implementation of the set guidelines in the administration of the test.

3. During the actual test, all monitors are advised to exhaust all means to cover as many schools as they can.

4. All expenses incurred for the conduct of the activities thereto are charged against local funds subject to the usual accounting and auditing rules and procedure

CHANGES IN AND ADDITIONAL INFORMATION TO DEPED MEMORANDUM NO. 1, S. 2016
(Administration of the Language Assessment for Primary Grades (LAPG) and the National Achievement Test for Grade Six (NAT G6) for School Year 2015-2016)

Public and Private Elementary and Secondary Schools Heads
All Others Concerned

1. The Department of Education (DepEd), through the Bureau of Education Assessment, formerly the National Educational Testing and Research Center, has announced the following changes in DepEd Memorandum No. 1, s. 2016:

- a. Postponement of the administration of the LAPG, that is, from March 8, 2016 to **June 15, 2016**, and administration of NAT G6 from March 10, 2016 to **June 17, 2016**; and
- b. Change in the examinees for LAPG to all **Grade Four learners** in all public schools, and change in the examinees for NAT G6 to all **Grade Seven learners** in all public and private schools nationwide

2. Further, additional NAT for Grade Ten (NAT G10) shall be administered on **June 23, 2016** to select learners in select public and private secondary schools nationwide.

3. Therefore, the new Table in Item No. 1 of DM No. 1, s. 2016 shall be read as follows:

Test	Date of Administration	Examinees
LAPG	June 15, 2016	All Grade Four learners in all public schools nationwide
NAT G 6	June 17, 2016	All Grade Seven learners in all public and private schools nationwide
NAT G10	June 23, 2016	Select Grade 11 learners in select public and private secondary schools nationwide

4. All test takers shall indicate in their respective answer sheets the schools where they completed their Grades Three, Six and Ten Curricula.

5. Submission of data to BEA-Education Assessment Division (BEA-EAD) is until **March 15, 2016**.
