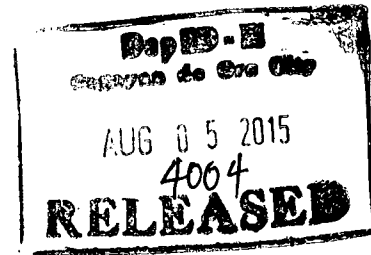

Subject : **Regional Musabaqah**

1. DepED Regional Office 10 shall conduct a **Regional Musabaqah** this coming October 22-23, 2015. This activity will be held at Kauswagan Central School, Lanao del Norte Division.
2. The Regional Musabaqah aims to:
 - a. provide the Muslim learners with appropriate and relevant opportunities through a competition;
 - b. showcase various products and performances as evidence of the pupils/students learning;
 - c. strengthen and upgrade the pupils level of competence in facing life's challenges;
 - d. encourage ALIVE teachers to create a satisfactory teaching and learning activities in the ALIVE Program; and
 - e. reinforce support of administrators, key officials, parents and communities to the ALIVE Program.
3. Expenses incurred such as prizes, supplies and materials, transportation, foods, accommodation and honorarium of judges and other involved in the activity, and other supplemental expenses shall be charged against Madrasah Regional Support Funds while board and lodging, travelling, and other related expenses of participants shall be charged to Madrasah Division Support Funds subject to the usual accounting and auditing rules and regulations.
4. Participants and officials shall make their own arrangements for board and lodging during the event.
5. The participants to this activity are the Division ALIVE coordinators and division first place winner pupils with their teacher coaches.

6. Each Division through the Division ALIVE coordinator should bring documents duly signed by the Schools Division Superintendent certifying that their contestants are officially enrolled for SY 2015-2016.
7. Division ALIVE coordinators shall submit the official list of their respective delegation to this Office (Attention: Chief, CLMD) on or before October 9, 2015.
8. The following are the mechanics and guidelines for the competition:

Category	Mechanics/Guidelines
Alpha Touch	The materials are provided by each Division, using illustration board and A4 size bond paper. The Regional Facilitator mixes them and distribute to all contestant as they take their turns.
Qur'an Memorization (HIFDUL QUR'AN)	The coverage of the contest includes Surah At-zalzalah, Surah At-tin, Surah As-Sharh.
Call to Prayer (ADHAN)	Maximum of 3 minutes is given for each entry including the preparation. Exceeding time, 0.5 will be deducted from the total score.
Qur'an Reading (QUIRA-ATUL QUR'AN)	The coverage of the contest includes Surah At-Tariq, Surah Al-A'La, Surah Al-Lal.
Arabic Spelling (IMLAH)	The ALIVE implementing Divisions are requested to submit on or before September 30, 2015 ten (10) questions and answers for Easy Category (Noun with 3 syllables), and five (5) questions and answers each for Average (Noun with 4 syllables) and five (5) Difficult questions and answers (Noun with 5 syllables) rounds. Clincher can be taken from the three (3) categories.
Islamic Values Quiz Bee	The ALIVE implementing Divisions are requested to submit at least ten (10) Q &A categorized into easy, average, difficult rounds on or before September 30, 2015. Coverage of the Q & A is Levels 1-III.
Display Board	Vertical Layout 48 X 36 inches, Font size 16-18 Arial (Tarpaulin) to showcase Division Best Practices of ALIVE Program.

9. Immediate dissemination and compliance of this Memorandum is directed.
