COVID FLIRT VARIANT

To: Public Schools District Supervisors/Districts In-charge Principals/School Heads

- 1. The Bureau alerts all concerned agencies of a new COVID-19 variant, the FLiRT Family and Subvariants. The acronym "FLiRT" stems from the technical names for the variant's spike protein mutation or the specific amino changes called "FLips" This term is now being used to describe a whole family of different variants including KP.2, JN.1.7, and any other variants starting with KP or JN. Each amino acid has its own letter abbreviation in this case FLiRT is F456L + R346T; or Phenylalanine (F) to Leucine (L) at position 456 and Arginine (r) to Threonine at position 346 "FLiRT".
- 2. Despite its playful name, the new set of COVID-19 variants are nothing to joke about. It is important to take precautions against COVID-19 and keep up to date with vaccination to prevent severe disease and complications.
- 3. The Department of Health mandates vigilance and awareness for all, especially those who are planning to travel abroad. Practice basic health measures such as frequent handwashing, coughing etiquette, and vigilance in crowded situations and getting in contact with people with flu like symptoms. Submit for screenings at Points of Entry such as Sea Ports and International Airports if necessary.
- 4. Based on reports, FLiRT Variants have been detected in Singapore, Thailand, India, China, HongKong, Nepal, The United States and 14 countries in Europe, including the United Kingdom.
- 5. The Bureau reminds that all travelers should complete the health questionnaire available on the e-travel application website.

Mandate

The Bureau of Quarantine (BoQ) under the Department of Health (DOH), with the entergory of a first-class line boreou, shall have a nationwide scope of function and international commitment in accord with the International Health Regulations (HiR) of the World Health Organization (WHO).

The Bureau is authorized to promulgate rules and regulations (apprehension, detention or surveillance) as necessary to provent the introduction, transmission or spread of "public health emergencies id international concern" from foreign countries into the Philippines.

Jurisdiction and Functions of the Europa

The examination at posts of entry and exit in the Philippines of incoming and outgoing vessels and aircraft.

The necessary surveillance over their sanitary conditions, as well as over their cargnes, passengers, crews, and all personal effects, and

The issuance of quarantine certificates, bills of health, or other equivalent documents shall be vested in and be conducted by the Burcan.

This Bureau shall have authority over incoming and outgoing vessels both domestic and foreign, including those of the enry and savy, their wharfage and anchorage, and over aircraft and airports, insofar as it is necessary for the proper enersy of the provisions of this Act.

SUBJECT: HEIGHTENED ALERT FOR COVID FLIRT VARIANT

We are facing a new COVID-19 strain that has the KP.1 and KP.2 variations, which are part of a newly discovered subvariants identified as "FLiRT," a novel virus that is spreading globally. They came from the JN.1 subvariant, which first became known in late 2023 and was responsible for this year's earlier infection increase.

In light of this, all stations have been directed to conduct thorough screening at Points of Entry for arriving visitors originating from countries where COVID FLiRT incidents have been detected. The general public should take basic health measures such as frequent hand washing, coughing etiquette, avoiding crowded situations and getting in contact with people with flu like symptoms.

All travelers must be reminded to complete the health questionnaire available on the e-travel application.
