The training aims to upgrade the participants' musical and instructional competencies and skills in teaching the K to 12 Music Education Curriculum on the following courses:


1. Music Theory

1 Pursuant to DepED Memorandum No. 77, s. 2013 re MUSIC EDUCATION TRAINING FOR GRADES 7 & 8 MUSIC TEACHERS NATIONWIDE, this Office had sent teacher participants to Ateneo de Cebu last May 20-24, 2013 to attend the said 5 day training.
