MID-YEAR AGENCY BUDGET PERFORMANCE REVIEW (APR) AND PROGRAM IMPLEMENTATION REVIEW (PIR) FOR FIRST SEMESTER FY 2024

To: All ExeCom, ProgCom Members

All Program Holders All ProgCom TWG All Others Concerned

- Pursuant to Section 3.17.5 of the 2024 DBM National Budget Circular No. 592 dated January 2, 2024 or the Guidelines on the Release of Funds for FY 2024, which states that, "Agency Performance Reviews (APRs) covering the current year: First Semester APR shall be conducted on or before September 15 of the current year," this division through the Budget Office shall conduct a Mid-Year Agency Budget Performance Review (APR) and Program Implementation Review (PIR) First Semester FY 2024 on July 30-31, 2024. The venue shall be announced in a separate memo.
- Relative to DepEd Order No.029, s.2022 titled Adoption of the Basic Education 2. Monitoring and Evaluation Framework (BEMEF) that aims to guide all operating units across governance levels in the conduct of Monitoring and Evaluation (M&E) initiatives, this Office shall implement Program Implementation Review (PIR) as the platform of the Division and Schools to report the accomplishments of outputs in terms of efficiency and corresponding budget utilization.
- With this, the Division Monitoring, Evaluation, and Adjustment (MEA) that the SDO is implementing which aims to monitor and evaluate the implementation of Programs, Projects, and Activities (PPAs) at the Division and Schools shall now transition to Program Implementation Review (PIR).
- The objectives in the conduct of APR and PIR are as follows: 4.
 - i. report the status of the major programs, projects, and activities based on the implementation plan, and committed outputs;
 - ii. present the status of completed outputs, ongoing outputs, scheduled outputs, additional outputs, and terminated outputs;
 - iii. present the overall assessments of PPAs;
 - iv. present the issues and concerns in the implementation of the PPAs; and
 - v. present the reasons for underachievement/overachievement and the catch-up/action plan to increase budget utilization rate (BUR)

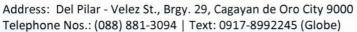
