Date: February 16, 2015

1. This office announces the Search for the Best School – Based Feeding Program implementing School for SY 2014 -2015
2. Seventy five (75) identified schools from the 23 districts of Misamis Oriental are recipients of the School Based Feeding Program for SY 2014 -2015 that started last August 18, 2014 and will end up on February 27, 2015 or after completing the required 120 feeding days.
3. Each district should be represented by one (1) selected best performing school from the district.
4. All selected participating schools should submit a folder of accomplishments where the judges could select the top five (5) best implementing school for the division.
Deadline for submission of entries will be on or before March 3, 2015.
5. The top 5 schools will be visited by the Board of Judges on March 9 – 13, 2015 for final evaluation. Actual feeding during the time of visit will be required for the judges to see pre and post feeding activities.
6. Enclosed are the Criteria for Judging and the Members of the Board of Judges.
7. Wide dissemination of this memorandum is hereby enjoined.
