Scanned copies of these documents need to be uploaded and stored online.

To upload and store files, access www.depedmisor.net/online-forms.html. Click on E-copy of School Forms. The school needs to login the email account of the school's ICT coordinator to access the folder for uploading/saving of files. In saving a file, the following must be observed.
